ARTICLES OF ORGANIZATION OF TOWNSEND PARTNERS, LLC

The undersigned authorized representative hereby executes these Articles of Organization s of the SECRETARY OF ST. ("Articles") for the purpose of forming a limited liability company in accordance with the laws of the State of Florida.

ARTICLE I

Name

The name of this limited liability company (the "Company") shall be:

ARTICLE II

Principal Office and Mailing Address
