ARTICLE I

NAME

ARTICLE III
NEW MEMBERS

- (B) the expiration of the term of the Company ; or
- (C) the death, retirement, or resignation of a member, if the remaining members do not vote unanimously to continue the business of the Company.

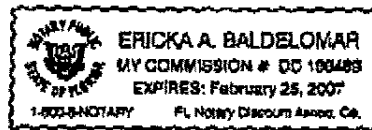

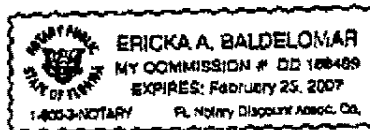
