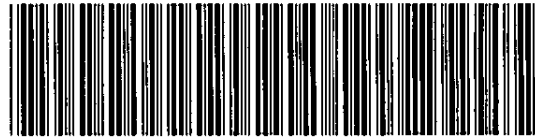

**SECOND AMENDMENT TO ARTICLES OF ORGANIZATION
OF
6650 WEST 20 AVENUE, LLC**

Pursuant to the provisions of Section 605, Florida Statutes, the undersigned, **6650 WEST 20 AVENUE, LLC, a Florida limited liability company** (hereinafter the "Company"), hereby adopts the following Second Amendment to the Articles of Organization of the Company:

FIRST:

The name of the limited liability company is 6650 West 20 Avenue, LLC.

SECOND:

The date of filing of the Articles of Organization of the Company with the Florida Secretary of State was April 11, 2005.

THIRD:

The sole and Managing Member of the Company, being InterAmerican Hotels Corp. ("IAHC"), previously adopted the following Amendments to its Articles of Organization of the Company as follows:

(A) Articles of Amendment to Articles of Organization of the Company which were filed on June 8, 2005, with the Florida Secretary of State, amending the Articles of Organization by adding a new ARTICLE VII to the Articles of Amendment with respect to Restrictions while Mortgage Obligations are Outstanding (the "First Amendment").

FOURTH:

The sole and Managing Member of the Company hereby amends ARTICLE VII of the First Amendment to the Articles of Organization, as follows:

(A) All references to the name "GMAC Commercial Mortgage Bank, a Utah industrial bank ("GMAC"), contained in Article VII of the Second Amendment to the Articles of Organization entitled Restrictions While Mortgage Obligations Are Outstanding, are hereby deleted, and in its place and stead the name "Wells Fargo Bank, a National Association" is hereby inserted (the "Second Amendment").

The foregoing Second Amendment to the Articles of Organization of the Company was duly and unanimously authorized, adopted and approved by its sole and Managing Member, IAHC, acting on behalf of the Company.

All other provisions of the Articles of Organization of the Company, as amended by the First Amendment and further amended by this Second Amendment, shall remain in full force and effect without any modification thereof.

IN WITNESS WHEREOF, the undersigned, IAHC, being the sole and Managing Member of the Company, has executed this Second Amendment to the Articles of Organization of the Company on behalf of the Company, as of the 22nd day of July, 2015.
