The name of the Company shall be: **Cogno Carta, LLC.**

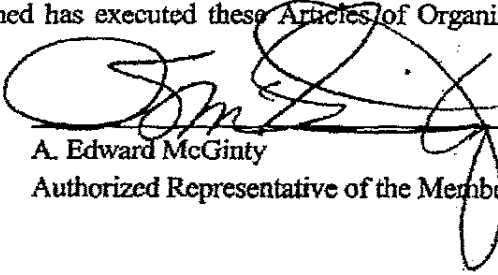
ARTICLE II

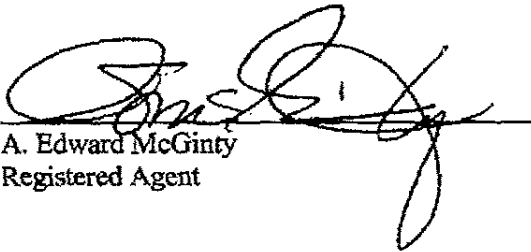
