**ARTICLE 1 - NAME**

The name of the limited liability company shall be THE LUNCH BOX, LLC, (hereinafter, "Company").

**ARTICLE 6 - PURPOSE**

This Company shall be permitted to engage in any and lawful activities in the State of Florida.

**ARTICLE 7 - REGULATIONS**
