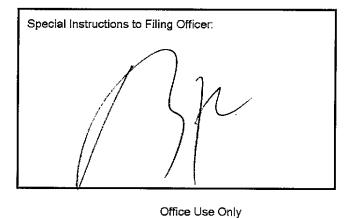

# ARTICLES OF ORGANIZATION FOR NW 30™ AVE., LLC A FLORIDA LIMITED LIABILITY COMPANY

## ARTICLE I. NAME

The name of the Limited Liability Company is "NW 30th Ave., LLC" (the "Company")

## ARTICLE II. ADDRESS
