AGREEMENT AND PLAN OF MERGER AMONG

MARTIN STREET APARTMENTS NORTH, LLC
(a Florida limited liability company)

AND

MARTIN STREET APARTMENTS MIDDLE, LLC
(a Florida limited liability company)

AND

MARTIN STREET APARTMENTS SOUTH, LLC (a Florida limited liability company)

Agreement and Plan of Merger dated January 3, 2007, among MARTIN STREET APARTMENTS NORTH, LLC, a Florida limited liability company ("MSA North"), MARTIN STREET APARTMENTS MIDDLE, LLC, a Florida limited liability company ("MSA Middle"), and MARTIN STREET APARTMENTS SOUTH, LLC a Florida limited liability company ("MSA South").

AGREEMENT

In consideration of the mutual covenants set forth in this Agreement, the parties agree as follows:

- 1. In accordance with the provisions of this Agreement, Chapter 608, Florida Statutes, the Effective Time (as defined below), MSA North, MSA Middle and MSA South shall be merged with and into MSA Middle (the "Merger"), the separate and corporate existence of MSA North and MSA South shall cease, and MSA Middle (the "Surviving Entity") shall continue its existence pursuant to the laws of Florida under its present name. (MSA North, MSA Middle and MSA South are collectively referred to as the "Constituent Entities").
- 2. The Merger shall become effective as of the date the articles of merger are filed with the Secretary of State of Florida (the "Effective Time").
- 3. The Surviving Entity shall possess and retain every interest in all assets and property of every description. The rights, privileges, immunities, powers, franchises and authority, of a public as well as private nature of each of the Constituent Entities shall be vested in the Surviving Entity without further act or deed. The title to and any interest in all real estate vested in either of the Constituent Entities shall not revert or in any way be impaired by reason of the Merger.
- 4. All obligations belonging to or due to each of the Constituent Entities shall be vested in the Surviving Entity without further act or deed, and the Surviving Entity shall be liable for all of the obligations of each of the Constituent Entities existing as of the Effective Time.

- 5. At the Effective Time, by virtue of the Merger and without any action on the part of the parties or otherwise:
 - (a) each issued and outstanding membership interest of MSA North and MSA South Company shall be cancelled without payment of any consideration and without any conversion; and
 - (b) each membership interest of MSA Middle shall remain issued and outstanding.
- 6. The articles of organization of MSA Middle in effect immediately prior to the Effective Time shall continue without change and be the articles of organization of the Surviving Entity.
- 7. This document may be executed in one or more counterparts, a complete set of which shall constitute one original.
