Pursuant to the provisions of section 608.4115 of the Florida Statutes, HLH Global, LLC, a Florida limited liability company (the "Company"), adopts the following Articles of Correction to its Articles of Organization which were filed with the Florida Department of State on April 13, 2005, as document number L05000036215.

FIRST: Article III of the Articles of Organization of the Company is corrected as follows:

Article III
Management

The Company shall be manager managed. The initial Manager of the Company is Larry Strulowitz. The number of Managers may be increased or diminished from time to time by the Members. The Manager or Managers shall be appointed by the Members and shall serve until the first annual meeting of the Members, or until his successor is elected and qualified.
