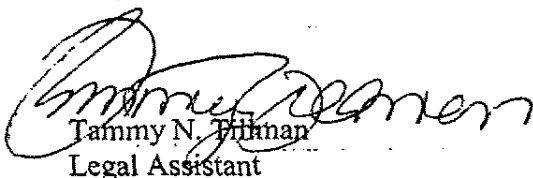

Purpose

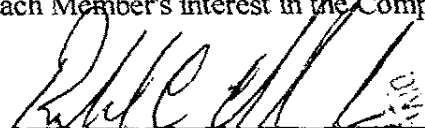

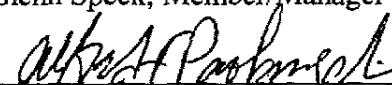
