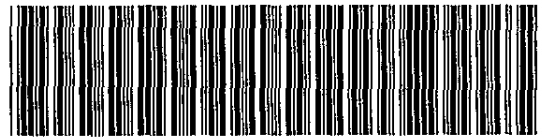

THE PRESERVE AT SAND CLIFFS, LLC

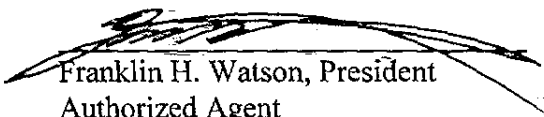
