**ARTICLE IV-PURPOSE**

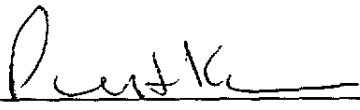

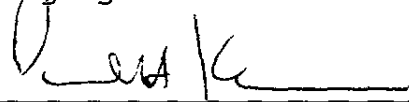
#### ARTICLE VII-INDEMNIFICATION
