**ARTICLES OF ORGANIZATION**

THE UNDERSIGNED, desiring to form a Limited Liability Company under and pursuant to Florida Statute 608 entitled the Florida Limited Liability Company Act, do hereby adopt the following Articles of Organization for such company

**ARTICLE I-NAME**

The name of this Company shall be NUTRITIONAL DREAMS, LLC.

**ARTICLE II-DURATION/CONTINUATION**
