## ARTICLES OF ORGANIZATION

The undersigned subscriber, ARTHUR S. ZAGER, a natural person competent to contract, herewith files these Articles of Organization pursuant to Section 608.407 Florida Statutes for such organization.

## ARTICLE ONE. Name.

The name of the organization is THE FAST SIDE, LLC. The business address of the organization is 470 W. Dearborn Street, Englewood, Florida 34223, the mailing address is 1730 Manasota Beach Road #201, Englewood, Florida 34223, and such other and further addresses as shall be adopted by the manager from time to time.

#### ARTICLE TWO. Nature of Business.

The general business to be transacted by this organization is as follows:
