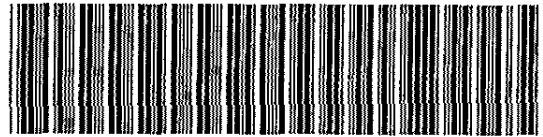



ARTICLE VIII – MEMBERS LIMITED LIABILITY


