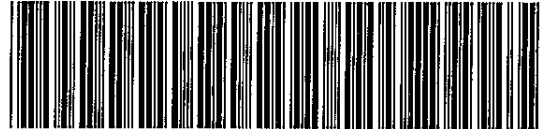

ARTICLES OF ORGANIZATION OF WEST NEW YORK, LLC

Article I

The name of the limited liability company ("Company") is WEST NEW YORK, LLC.

Article II
