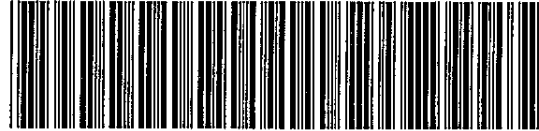

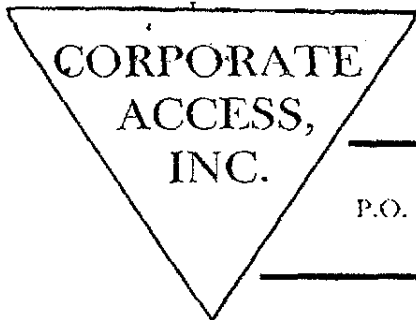

"The name of the limited liability company is **ISLAND SUPPLY Co., LLC."**

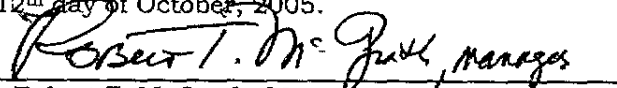
4. The terms of Article IV of the Articles of Organization are hereby deleted in their entirety and the following substituted in lieu thereof:

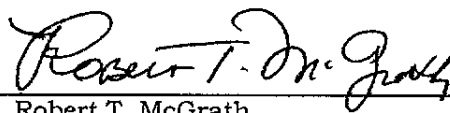
5. The foregoing amendment was approved by the Managing Member of the Company on the 12th day of October, 2005.
