

ARTICLES OF ORGANIZATION OF NS. LLC

The undersigned, for the purpose of forming a limited liability company under the Figure Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I - NAME

The name of the limited liability company shall be NS, LLC, ("company").

ARTICLE II - ADDRESS

The company shall be dissolved on the death, bankruptcy, or dissolution of a member or manager, or on the occurrence of any other event that terminates the continued membership of a member in the company, unless the business of the company is continued by a majority vote of the remaining members.
