

ARTICLES OF ORGANIZATION OF VENTURES INDIAN ROCKS I, LLC

- COSTAN S AND STAN S AND STAN S AND S Name. The name of this limited liability company is VENTURE ROCKS I, LLC (the "Company"), and it shall be formed as a limited liability company under Chapter 608 of the laws of the State of Florida.
