**AMENDED AND RESTATED
ARTICLES OF ORGANIZATION
OF
POTTS REAL ESTATE SERVICES, LLC**

The undersigned member to these Amended and Restated Articles of Organization, being a natural person competent to contract as such under the laws of the State of Florida, and the sole member and manager of this company, hereby amends and restates the Articles of Organization filed with the Secretary of State on April 15, 2005 in their entirety, pursuant to Section 608.411, Florida Statutes, as follows:

ARTICLE I

Name. The name of the limited liability company shall be NANCY HUNT POTTS, LLC ("Company").

ARTICLE II

Address. The mailing address and street address of the principal office of the Company shall be 5256 Timberview Terrace, Orlando, FL 32819.

ARTICLE III

Duration. The Company shall commence its existence on the date these Articles of Organization are filed by the Florida Department of State. The Company's existence shall be perpetual unless the Company is earlier dissolved as provided in the operating agreement of the Company.

ARTICLE IV


