Or the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member, or the occurrence of any other event that terminates the continued membership of a mainter in the Limited Liability Company, the remaining members shall have the right to continue the business on unanimous consent of the remaining members.

Every member, upon the increase in the capital of the Limited Liability Company whether it be previously authorized in the Articles of Organization filed originally or authorized by amendment thereto, shall have the right to purchase his pro-rate share thereof at the same price and under the same terms at which it is offered to others.

Article IX-Beginning of LLC's Existence

The date when the existence of this Limited Liability Company shall begin business shall be the time of filing of these Articles of Organization by the Department of State.

Article X-Limitation of Liability

Each member or manager, in consideration for his services, shall, in the absence of frend, be indemnified, whether then in office or not, for the reasonable cost and expenses inquired by him in connection with the defense of, or for advice concerning any claim asserted or proceeding brought against him by reason of his being or having been a member or manager of the Limited Liability Company or of any subsidiary, whether or not wholly owned, to the maximum extent permitted by law. The foregoing right of intermification shall be inclusive of any other rights to which any member or manager may be entitled as a matter of law.

The rights accruing to any person under the foregoing provisions shall not exclude any other right to which he may be lawfully entitled, nor shall anything herein contained requiet the right of the Limited Liability Company to indemnify or reimburse such person in any proper case even though not specifically provided for herein.

No contract or other transaction between the Limited Liability Company and other entities, in the absence of fraud, shall be affected or invalidated by the fact that any one or more of the members or managers of this Limited Liability Company is or are interested in a contract or transaction, individually or jointly, may be a party or parties to or may be interested in such contract, act or transaction, or in any way connected with such person or person's firm or corporation, and each and every person who may become a member or manager of the Limited Liability Company is hereby relieved from any liability that might otherwise exist from this contracting with the company for the benefit of himself or any firm, association or corporation in which he may be in any way ingrested, provided by the fact that he is so interested shall be disclosed or shall be known to the other members and managers.

Article XII-Amendments

These Articles of Organization may be amended in the manner provided by law. Every amendment shall be approved by the unanimous vote of all its members, unless all the manners sign a written statement manifesting their intention that a certain amendment of these Articles of Organization be made.

Article XIII - Profits and Losses

Prefit Sharing: The members shall be entitled to the net profits arising from the operation of the Limited Liability Company's business that remain after payment of the expenses of conducting its business. Each member shall be entitled to a distributive share of the profits. The distributive share of the profits shall be determined and paid to the members after year's end, according to their participative share.
