ARTICLES OF ORGANIZATION FOR FLORIDA LIMITED LIABILITY COMPANY

Except for any person who is or was a managing member of the Company, or any person who is or was serving at the request of the Company, or any person who is or was a director or officer or member of another company, corporation, no employee or agent of the Company may apply for indemnification or advancement of expenses to any court of competent jurisdiction.
