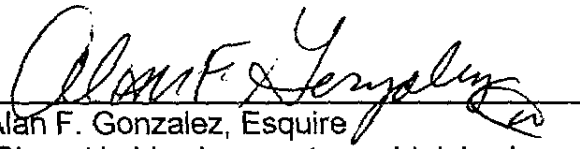

The members reserve the right to amend, alter, change or repeal any provisions contained in these Articles of Organization through a simple majority vote of the members.

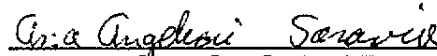
