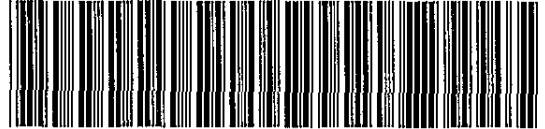

ARTICLES OF ORGANIZATION
OF
REDLAND PROFESSIONAL PARK, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE 1 - NAME

The name of the limited liability company shall be **REDLAND PROFESSIONAL PARK, LLC**, ("Company").

ARTICLE 2 - ADDRESS

The principal place of business of the Company in Florida shall be 8725 Northwest 18th Terrace, #105, Miami, Florida 33172 and the mailing address shall be the same.

ARTICLE 3 - EFFECTIVE DATE


