#### ARTICLES OF ORGANIZATION OF LELY LEGACY 103, LLC

#### ARTICLE I: NAME AND PRINCIPAL PLACE OF BUSINESS

- file a voluntary petition or otherwise initiate proceedings to have the Company (iii) adjudicated bankrupt or insolvent, or consent to the institution of bankruptcy or insolvency proceedings against the Company, or file a petition seeking or consenting to reorganization or relief of the Company as debtor under any applicable federal or state law relating to bankruptcy, insolvency, or other relief for debtors with respect to the Company; or seek or consent to the appointment of any trustee, receiver, conservator, assignee, sequestrator, custodian, liquidator (or other similar official) of the Company or of all or any substantial part of the properties and assets of the Company, or make any general assignment for the benefit of creditors of the Company, or admit in writing the inability of the Company to pay its debts generally as they become due or declare or effect a moratorium on the Company debt or take any action in furtherance of any action;

- (iv) amend, modify or alter these Articles; or
- (v) merge or consolidate with any other entity.

#### ARTICLE IV: EXERCISE OF POWERS/MANAGER

All limited liability company powers shall be exercised by or under the authority of, and the business and affairs of this limited liability company shall be managed under the direction of, the Manager of this limited liability company. The initial Manager shall be <u>DENNIS PASSINI</u>.

#### **ARTICLE V: DURATION**
