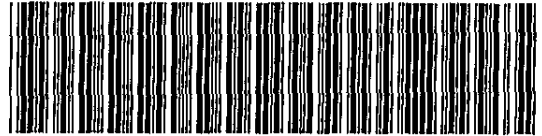

**ARTICLES OF ORGANIZATION  
OF  
WW PARTNERS, LLC**
