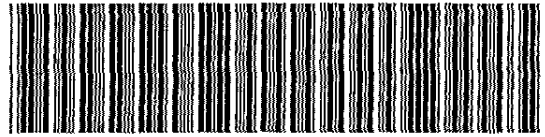



ARTICLE VI - ADMISSION OF ADDITIONAL MEMBERS


The right if given, of the members to add additional members and the terms and conditions of such admissions shall be in accordance with the Regulations of the Limited Liability Company.
