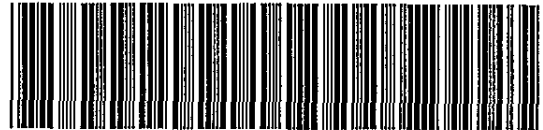

## ARTICLES OF ORGANIZATION

OF

### JP COMMERCIAL BROKERAGE, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

#### ARTICLE I - NAME

The name of the limited liability company shall be **JP COMMERCIAL BROKERAGE, LLC** ("Company").

#### ARTICLE II - ADDRESS

The mailing address and street address of the principal office of the Company shall be 1935 Red Bank Road, North Palm Beach, FL 33408.

#### ARTICLE III - DURATION

The Company shall commence its existence on the date the Articles of Organization are filed by the Florida Department of State. The Company's existence shall be perpetual unless the Company is earlier dissolved as provided in the Operating Agreement.

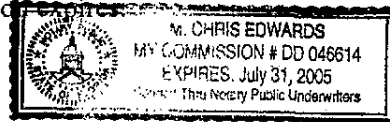
