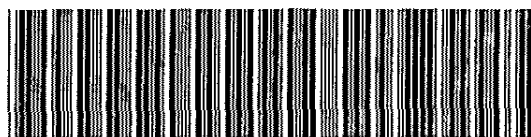


First: The Articles of Organization were filed on April 19, 2005 and assigned Document Number L05000038394.
