## ARTICLES OF ORGANIZATION

OF

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, hereby makes, acknowledges, and files the following Articles of Organization.

#### ARTICLE I -- NAME

The name of the limited liability company shall be THALASSA REALTY GROUP INTERNATIONAL, LLC (the "Company").

#### ARTICLE II -- ADDRESS

The Company shall be a manager-managed company and shall be managed by at least one Manager who may, but need not, be a Member, in accordance with the Operating Agreement adopted by the Members for the management of the business and affairs of the Company.
