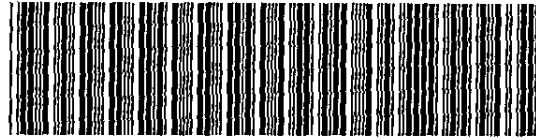


1. **Name.** The name of this company shall be Benedict Entertainment Group LLC


