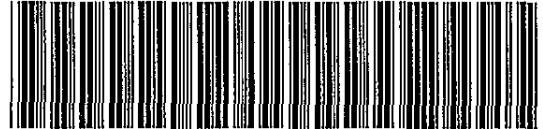

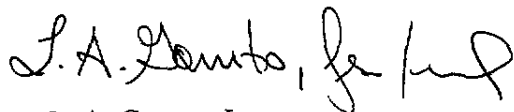

of

A Florida Limited Liability Company

ARTICLE 1
NAME

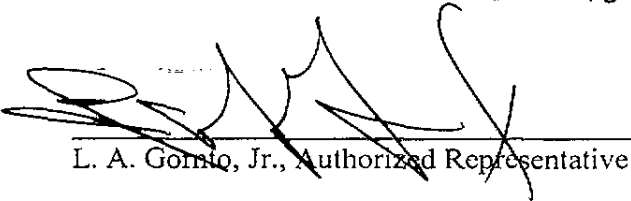

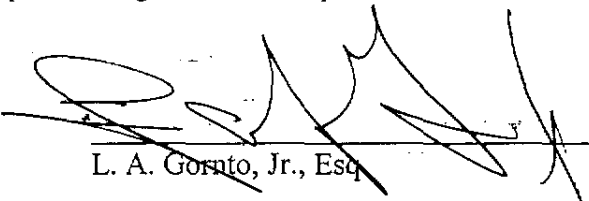
