**ARTICLES OF ORGANIZATION
OF
Signature Images, L.L.C.**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I -- NAME

The name of the limited liability company shall be Signature Images, L.L.C..

ARTICLE II -- ADDRESS

The mailing and street address of the principal office is 8560 SE 155th Place, Summerfield, FL 34491.

ARTICLE III - PURPOSE

The limited liability company is organized to operate for any lawful purpose.

ARTICLE IV-DURATION

The limited liability company shall commence its existence as of April 6, 2005. The company's existence shall be perpetual unless the company is dissolved earlier as provided in these Articles of Organization or in any Operating Agreement.

ARTICLE V -- REGISTERED OFFICE AND AGENT

The name of the registered agent and the street address of the registered agent of the limited liability company in the State of Florida is: Judy L. Watkins of 8560 SE 155th Place, Summerfield, FL 34491.

ARTICLE VI -- INITIAL AND ADDITIONAL CAPITAL CONTRIBUTIONS

Each member shall make initial capital contributions in cash, services and/or property, however, each member shall continue to make additional capital contributions to the limited liability company only with the consent of the members having sixty-six and one third percent (66 1/3%) of the capital interests of the company entitled to vote or as otherwise provided in the Operating Agreement.

ARTICLE VII -- ADMISSION OF NEW MEMBERS

Except as set forth in the Operating Agreement, no additional members shall be admitted to the company except with the written consent of the members having sixty-six and one third percent (66 1/3%) of the capital interests of the company entitled to vote and on the terms and conditions as shall be determined by those members. A member may transfer his or her interest in the company as set forth in the Operating Agreement and/or Bylaws of the company, but the transferee shall have no right to participate in the management of the business and affairs of the company or become a member unless members having sixty-six and one third percent (66 1/3%) of the capital interests of the company entitled to vote other than the member proposing to dispose of his or her interest approve of the proposed transfer by written consent.

ARTICLE VIII -- MEMBERS' RIGHT TO CONTINUE BUSINESS

The company shall not be dissolved on the death, bankruptcy, or dissolution of a member, or on the occurrence of any other event that terminates the continued membership of a member in the company, unless otherwise stated in the Operating Agreement or Bylaws, and only by a unanimous vote of the remaining members.

ARTICLE VIV - MEMBERS/MANAGEMENT

The limited liability company shall be initially managed by the following persons: Michael K. Gerbig and Judy L. Watkins of 8560 SE 155th Place, Summerfield, FL 34491. The company shall continue to be managed by the manager unless otherwise mandated in accordance with the Operating Agreement and Bylaws adopted by the members for the management of the business and affairs of the company. The Operating Agreement and Bylaws may contain any provisions for the regulation and management of the affairs of the limited liability company not inconsistent with law or these Articles of Organization.

ARTICLE X-AMENDMENT, MODIFICATION, OR REPEAL OF THE ARTICLES OF ORGANIZATION, THE OPERATING AGREEMENT, OR BYLAWS

Except as set forth in the Operating Agreement and/or Bylaws, no amendment, modification or repeal of the Articles of Organization, Operating Agreement or Bylaws may be made without the written consent of the members having sixty-six and one third percent (66 1/3%) of the capital interests of the company entitled to vote and on the terms and conditions as shall be determined by the those members.

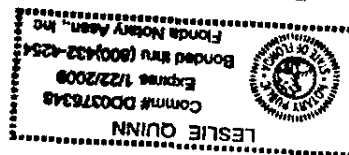

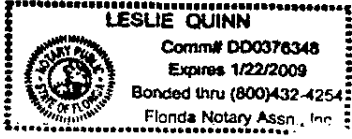
