ARTICLE I - NAME

The name of this limited liability company is: Doughmakers, LLC

ARTICLE II - PRINCIPAL PLACE OF BUSINESS

The mailing address and street address of the principal office of the Limited Liability Company is 250 N. Dixie Highway, #13, Hollywood, Florida 33020.

ARTICLE III - DURATION

The company shall commence its existence on the date these Articles of Organization are filed for the Florida Department of State. The Company's existence shall be perpetual unless the company is earlier dissolved as provided in these Articles of Organization.
