**ARTICLES OF ORGANIZATION OF
PROMISED LAND GROUP, LLC
A FLORIDA LIMITED LIABILITY COMPANY**

The undersigned desiring to form a Limited Liability Company under and pursuant to Section 608.404 of the Limited Liability Act, pursuant to Chapter 608 of the Florida Statutes, of the State of Florida, do hereby certify as follows:

FIRST: The name of said Limited Liability Company shall be PROMISED LAND GROUP, LLC, and the mailing address and the street address of the principal office of the limited liability company shall be: 1911 Harrison Street, Hollywood, Florida 33020

SECOND: PROMISED LAND GROUP, LLC, shall have a perpetual duration from the date of filing of these Articles of Organization.

THIRD: The purposes for which, PROMISED LAND GROUP, LLC is formed are:

(A) to purchase, sell real estate, and otherwise manage and hold real estate properties within the State of Florida, subject to such laws and;

(B) to engage in such other lawful acts or activities for which limited liability companies may be formed under Chapter 608 of the Statutes of the State of Florida.


FIFTH: This limited liability company shall be member-managed and will have one (1) managing-member, South Medley, Inc, a Florida Corporation


Designation and Acceptance of Registered Agent
