ARTICLE II



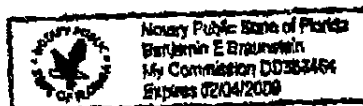
