
Article VI

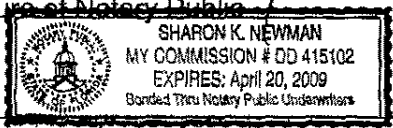
