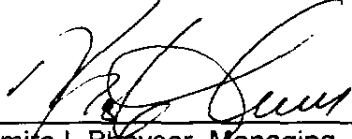

- 4) All other aspects of the limited liability company shall remain the same.

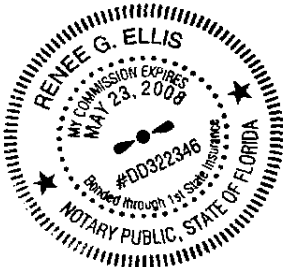
