**ARTICLES OF ORGANIZATION
OF

THE UNDERSIGNED MEMBER hereby adopts the following Articles of Incorporation for the purpose of forming a limited liability company under the Florida Limited Liability Company Act.

**ARTICLE I
Company Name and Principal Office**


