ARTICLE V - Admission of Additional Members:

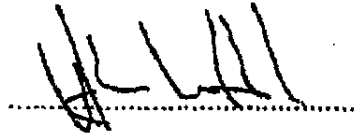

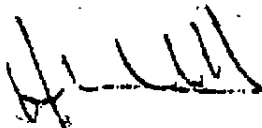
