## ARTICLES OF AMENDMENT TO THE ARTICLES OF ORGANIZATION OF VILLAS OF HIMES, LLC

Pursuant to the Florida Limited Liability Company Act, VILLAS OF HIMES, LLC, a Florida limited liability company (the "Company"), hereby adopts the following Articles of Amendment to its Articles of Organization:

FIRST: The name of the Company is: Villas of Himes, LLC

SECOND: The Articles of Organization of the Company were filed on April 22, 2005 and assigned document number L05000040217.

THIRD: Article 4 of the Articles of Organization of the Company is hereby amended and restated in its entirety as follows:

FOURTH: Article 5 of the Articles of Organization of the Company, as amended, iso hereby amended and restated in its entirety as follows:

FIFTH: Article 6 of the Articles of Organization of the Company is hereby amended and restated in its entirety as follows:

Management of the Company. The Company shall be managed by its members in accordance with the Operating Agreement adopted by all of the members and is, therefore, a member-managed company. BMJC, LLC, a Florida limited liability company, is the managing-member of the Company.

SIXTH: The foregoing amendment to the Company's Articles of Organization will become effective upon the filing of these Articles of Amendment to the Articles of Organization with the Florida Department of State.
