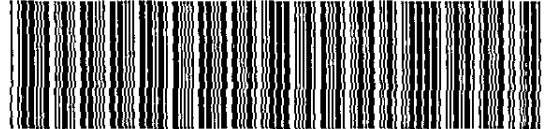

The name of the Limited Liability Company is BIRD 74, LLC (the "Company").


