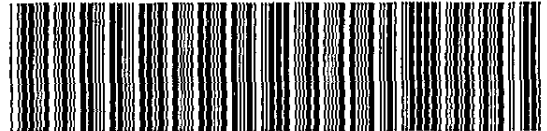

ARTICLE I — Name:

The name of the Limited Liability Company (hereinafter referred to as the "Company") is DUAL DIAGNOSIS RESOURCES AND RESEARCH, LLC

ARTICLE II — Duration:

The Company's period of duration shall be perpetual.

ARTICLE III — Address:


