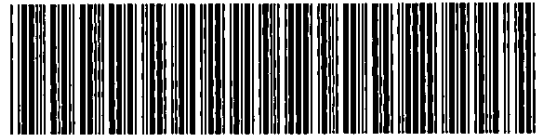


**ARTICLES OF AMENDMENT

4. These Articles of Amendment shall be effective when filed with the Florida Department of State.

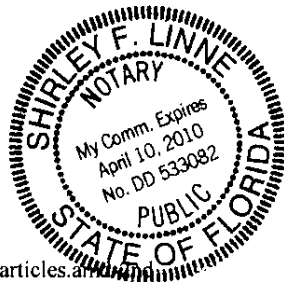


