

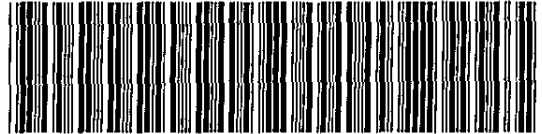


ARTICLE V
