The undersigned does hereby execute, acknowledge and file the following Amendment to the Articles of Organization of GLOBAL SECURE ASSEMBLIES, LLC.

1. The name of the Corporation is currently GLOBAL SECURE ASSEMBLIES, LLC.
2. The date of the filing of the Articles of Organization was April 25, 2005.
3. The Articles of Organization are amended as follows:

- a. By deleting all of Article I hereof, and by substituting in lieu thereof, all of

the following:

ARTICLE I
