# ARTICLES OF AMENDMENT TO ARTICLES OF ORGANIZATION FOR

#### HOLLOWS LANE, LLC

Pursuant to Section 608.411 of the Florida Limited Liability Company Act, the Articles of Organization for HOLLOWS LANE, LLC, which were originally filed with the Florida Secretary of State on April 25, 2005, are restated in their entirety to read as follows:

#### "ARTICLE I - NAME

#### **ARTICLE II - ADDRESS**

The Members of the Limited Liability Company shall have the right to withdraw as a member with (i) six (6) months prior notice, and (ii) with the unanimous consent of all the members.

#### **ARTICLE IX - DISTRIBUTION**

The purpose of the Limited Liability Company is to engage in one or more businesses and/or to invest and reinvest its assets. Accordingly, no distribution is contemplated. Notwithstanding the foregoing, the Board of Managers and ninety-eight percent (98%) of the members may consent to a distribution. All distributions shall be in the form of insurance company annuity contracts with the respective member as the

#### ARTICLE X - OFFICERS

The managers shall hold those offices and have those responsibilities accorded to them by the members of the Limited Liability Company, as set forth in the Regulations of the Limited Liability Company.
