ARTICLES OF ORGANIZATION

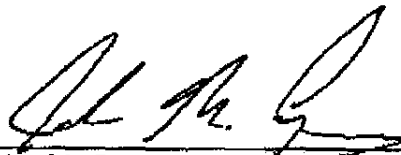

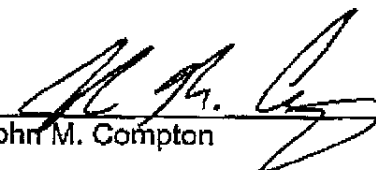
