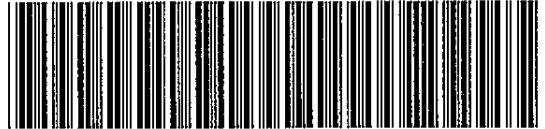

The mailing address and street address of the principal office of the Company is 11250 Citrus Grove Blvd., West Palm Beach, FL 33412.

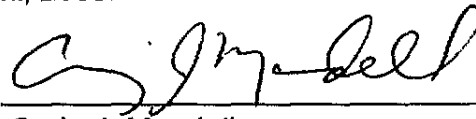

The Company is to be managed by one or more managers and is therefore a manager-managed company.

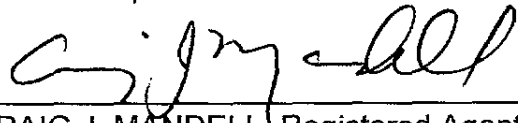
