

ARTICLES OF ORGANIZATION
OF

ARTICLE I - NAME

The name of this limited liability company is: Lago Tamarac, LLC

ARTICLE II - PRINCIPAL PLACE OF BUSINESS

ARTICLE III - DURATION


ARTICLE VI - MANAGEMENT


ARTICLE VII - ADMISSION OF ADDITIONAL MEMBERS
