ARTICLES OF AMENDMENT

The undersigned Members of DAVIE 2005 (the "Company") hereby amend the Articles of Organization as follows: *

*The Company was organized under the Laws of the State of Florida on 04/27/05

WHEREAS, RHON ERNEST-JONES CONSULTING ENGINEERS, INC. ("REJCE"), a Florida Corporation, has sold its Membership Interest in the Company and has resigned as Managing Member (a copy of the Resignation Letter is attached hereto and marked as Exhibit "A"); and

WHEREAS, CRAIG SHIPLE ENTERPRISES, INC. ("CSEI"), a Florida Corporation, has purchased the Membership Interest of REICE, making CRAIG SHIPLE ENTERPRISES, INC. a fifty percent (50%) Member of the Company,

WHEREAS, ENERGY CONSERVATION APPLICATIONS AND TECHNOLOGY SYSTEMS, INC. ("ECATS"), a Florida Corporation, owns beneficially and of record an equal fifty percent (50%) Membership Interest; and

WHEREAS, ECATS has agreed that CSEI is to be appointed as Managing Member and all acts and actions taken by CSEI will be binding upon the Company;

NOW THEREFORE, the Articles of Organization for DAVIE 2005, are hereby amended to reflect that REJCE has resigned as Managing Member, and has sold its Membership Interest to CSEL Further, the Company shall have two Members with equal fifty percent (50%) interests, the Members being ECATS and CSEI. The Company will be operated as a member operated company.
